JARA estimates 1.4% growth in fiscal 2013

The Japan Aluminum Alloy Refiners Association held a board of directors on March 21 in Osaka, where the presumption of secondary aluminum alloy demand in fiscal 2012, started in April 2012 and ended in March 2013, and its prediction in fiscal 2013, starts in April 2013 and ends in March 2014 were approved and revealed subsequently.

According to the announcement, the presumed demand in fiscal 2012 increased 2.9 per cent from a year earlier to 1,542,700 ton. In fiscal 2012, the domestic auto production showed doldrums with both the end of a helpful support program – government subsidiaries on purchases of environmentally friendly vehicles and the somber Chinese sales plummet by a fraying Tokyo-Beijing ties.

However, the overseas auto production showed a big increase, which helped powerfully the export of component parts. As a result, the association presumed the demand in fiscal 2012 increased 2.9 per cent from a year earlier to 1,542,700 ton.

Regarding to the demand in fiscal 2013, the association calculates to increase 1.4 per cent year on year to 1,564,500 ton. The bases of the calculation are;

- (1) Domestic auto production will stagnant but the export of assembly parts will be still pretty active brought by the swelling overseas auto production.
- (2) The demand for beverage aluminum can will move sideways.
- (3) The demand for steel will not change.

The table on page one shows the prediction of secondary aluminum alloy demand, on which 23 means fiscal 2011, 24 means fiscal 2012 and 25 means fiscal 2013. Top line shows cast, second die cast, third sheet and extrusion, fourth steel and others and bottom total. The right side figures are the comparison with the previous years.

The tonnage includes the consumption of imported ingot. Unit is ton.

Mino Industry Co., Limited revealed recently the buyout of the all shares of Furuchu Limited. Mino Industry Co., Limited (President, Mr. Jun Sugimoto, Nakatsugawa City Gifu-ken) was established in 1950, They are a famous aluminum diecaster in central Japan, and have factories in Thailand, China and the U.S. Their main products are smaller parts for automobile in central Japan

Furuchu Limited (President, Mr. Shoji Suda, Oyama City Tochigi-ken) is a timehonored diecaster in eastern Japan, which products are medium and larger size for truck and industrial machines. The unification of the two major diecasters would cover central and eastern Japan extensively with whole size diecasted products. The integration effects are greatly expected.

Impact of devaluated ven

Yen devaluated to \96.5/US dollar on March 12. It was the first time for past three years and seven months. Comparing with the start of 2012, yen has devaluated really 26.8 per cent. They say the lower yen stimulates business. On the other hand, the most imported goods would cost more, and we are afraid that the higher prices of imported goods, from various energy resources to Scotch whisky and wine, would depress the consumption.
